WHO IS NAEM?

NAEM is a professional association that empowers corporate leaders to advance environmental stewardship, create safe and healthy workplaces and promote global sustainability. As the largest community for Environmental, Health and Safety (EHS), and Sustainability decision-makers, NAEM provides peer-led educational conferences and an active network for sharing solutions to today's corporate EHS and Sustainability management challenges.

WHAT DOES NAEM DO?

For more than 20 years, NAEM has been dedicated to advancing the best practices in corporate EHS and Sustainability management. Through its research, benchmarking and decision-making tools, NAEM continues to empower EHS and Sustainability professionals to promote progressive policies, drive business value and fulfill a corporation's responsibility to society.

HOW MANY MEMBERS DOES NAEM HAVE?

Why does NAEM limit its membership to EHS and Sustainability practitioners?

At NAEM, the participation of consultants is limited to ensure that members will interact with corporate practitioners who have thoughtfully gone through the process in a real-world context. The consultants and service providers who do belong to the NAEM community have been vetted by corporate members as relevant experts in the field.

WHAT MAKES NAEM'S CONFERENCES DIFFERENT FROM OTHER EVENTS ABOUT EHS OR SUSTAINABILITY?

First, NAEM is the largest community for EHS and Sustainability decision-makers. Additionally, it uses a peer-driven approach to professional development. WHAT HAPPENS AT NAEM'S ANNUAL EHS MANAGEMENT FORUM?

WHAT IS ENVIRONMENTAL, HEALTH AND SAFETY (EHS) MANAGEMENT?

From an environmental standpoint, this involves creating a systematic approach for managing waste, complying with U. S. Environmental Protection Agency regulations and implementing sustainability initiatives. Strong EHS programs also include measures to address ergonomics, air quality and other aspects of the work environment that could affect the health and well-being of employees.

WHAT IS SUSTAINABILITY? HOW DOES IT RELATE TO EHS?

With the advent of sustainability, EHS leaders are increasingly responsible for designing and implementing strategies to take companies beyond compliance. These initiatives involve tasks such as developing a formal sustainability program, measuring a product's carbon footprint, engaging stakeholders and publicly reporting EHS and sustainability performance.

WHAT IS THE HISTORY OF THE ENVIRONMENTAL MANAGEMENT PROFESSION?

The corporate environmental management profession began in the 1970s, following the creation of the U.S. Environmental Protection Agency. In the beginning, companies needed engineering solutions to reduce pollution and manage waste from manufacturing processes. As the profession matured, however, environmental managers evolved into advocates for longer-term strategic thinking about how a company can remain profitable while minimizing its environmental impacts.

Today, these managers are the environmental leaders of the corporate world, marrying technical expertise with the management skills they need to translate policies like sustainability into systems that drive business value. Indeed, a survey of NAEM members in 2009 found that the majority of corporate sustainability initiatives – such as water conservation and reducing greenhouse gas emissions – were either being led by, or conducted with cooperation from, the EHS manager.

Environmental, Health and Safety (EHS)

Companies that aspire to be better environmental stewards typically invest in strong Environmental, Health and Safety (EHS) management. From an environmental standpoint, this involves creating a systematic approach for managing waste, complying with federal environmental regulations and implementing sustainability initiatives. Strong EHS programs also include measures to address ergonomics, air quality and other aspects of the work environment that could affect the health and well-being of employees.

The corporate EHS profession began in the 1970s following the creation of the U.S. Department of Environmental Protection. Today, EHS managers are the environmental leaders of the corporate world, advocating for strategic environmental policies, including corporate sustainability. Engineers or scientists by training, they bring a highly specialized skill set to their work, marrying technical expertise with the management skills they need to translate sustainability from policy into practice. Indeed, a survey of NAEM members in 2009 found that the majority of corporate sustainability initiatives – such as water conservation and reducing greenhouse gas emissions – were either being led by, or conducted with cooperation from, the EHS manager.
